

ORDINANCE NO. 1-2017

AN ORDINANCE OF THE BOROUGH OF KNOX, CLARION COUNTY, PENNSYLVANIA, AMENDING CHAPTER 18 OF THE BOROUGH CODE RELATING TO SEWER RATES AND CHAPTER 26, PART 2 OF THE BOROUGH CODE RELATING TO WATER RATES

IT IS HEREBY RESOLVED that the Borough of Knox amends the following section of Chapter 18 of the Borough Code, as follows:

§142. Rates. The rates for sewer for the properties served by Knox Borough sewers shall be as follows:

A. In order to apportion the annual sewer rental or charge imposed by §141 equitably among the properties served by Knox Borough sewers, the annual rental or charge shall, for every property served by the sewers, be fixed at 140% of the total face amount charged to such property for water consumed by such property during the previous month period.

B. Bills for sewer rentals or charges shall be rendered by the Borough Treasurer, monthly, after the first and before the 11th days of every month.

C. The rates for sewer set forth in this §142 may be amended from time to time by Resolution of the Borough Council.

IT IS HEREBY FURTHER RESOLVED that the Borough of Knox amends the following section of Chapter 26, Part 2 of the Borough Code, as follows:

§202. Rates. The rates for water furnished to all customers from the municipal water plant in any monthly period shall be as follows:

A. There shall be a minimum charge of \$18.70 for each residential, commercial, trailer park or motel using water supplied by the municipal water plant, which minimum charge shall be applicable for the first 1,000 gallons or any part thereof used in such monthly period.

B. There shall be an additional charge of \$4.00 per 1,000 gallons or any part thereof for water purchased in excess of an amount equal to 1,000 gallons multiplied by the number of dwelling units using water purchased by the customer.

C. Bills for water usage or charges shall be rendered by the water collection agent, monthly, after the first and before the 11th days of every month.

D. Bills will be due on the 15th of the month sent. On the 25th of the month following receipt of the penalty bill, water service will be terminated for all

unpaid bills. Partial payment of bills will not guarantee that water service be terminated.

E. The rates for water set forth in this §202 may be amended from time by Resolution of the Borough Council.

§203. Water Revenue Account. All monies so received by the Borough Treasurer pursuant to §202 herein shall be deposited by said Treasurer in a special account designated as "Water Revenue Account" of the Borough of Knox, and shall be used only for expansion, improvement or maintenance and repair of the water system.

§204. Declaration of Effectiveness. The established rates set forth in §202 shall be effective upon enactment and shall continue until amended by further action of the Borough Council of Knox Borough, Clarion County, Pennsylvania.

Any Section of Chapter 18 and/or any Section of Chapter 26, Part 2 not amended herein shall remain in full force and effect.


All Ordinances or parts thereof in conflict herewith be and the same are hereby repealed.


This Ordinance shall be effective within five (5) days after adopted by the Borough Council and approved by the Mayor.
